**Affidavit of Professor Richard J. Bonnie In Support Of
Motion Defendant's Motion For Reconsideration Of Their
Motion To Dismiss And For An Evidentiary Hearing**

1. My name is Richard J. Bonnie. I am the Harrison Foundation Professor of Medicine and Law, Professor of Psychiatry and Neurobehavioral Science, and Director of the Institute of Law, Psychiatry and Public Policy at the University of Virginia. I teach and write about criminal law, bioethics, and public policies relating to mental health, substance abuse, aging and public health. My curriculum vitae and a list of my publications are attached.

2. I have been actively involved in public service throughout my career. Among many other positions, I served as Associate Director of the National Commission on Marihuana and Drug Abuse (1971-73); Secretary of the first National Advisory Council on Drug Abuse (1975- 80); chair of the Virginia State Human Rights Committee responsible for protecting rights of persons with mental disabilities (1979-85); and chief advisor for the ABA Criminal Justice Mental Health Standards Project (1981-88). I am currently

chairing a Commission on Mental Health Law Reform at the request of the Chief Justice of Virginia.

3. I have served as an advisor to the American Psychiatric Association Council on Psychiatry and Law since 1979, received the APA Isaac Ray Award in 1998 for contributions to forensic psychiatry, and was awarded a special presidential commendation in 2003 for my contributions to American psychiatry. I have also served on the MacArthur Foundation Research Network on Mental Health and the Law (1988-96) and am currently participating in the MacArthur Foundation Research Network on Mandated Community Treatment and in a new MacArthur Foundation Initiative on Neuroscience and Law.

4. In 1991, I was elected to the Institute of Medicine of the National Academies. I have chaired numerous Academy studies on subjects ranging from elder mistreatment to underage drinking, and just completed chairing a major IOM study on tobacco policy. I received the Yarmolinsky Medal in 2002 for my contributions to the IOM and the National Academies.

5. I have authored and co-authored a number of relevant books, including *The Marijuana Conviction: The History of Marijuana Prohibition in the United States* (Lindesmith Center Drug Policy Classic, 1999), republishing *The Marihuana Conviction: The History of Marihuana Prohibition in the United States* (University Press of Virginia, 1974) and *Marijuana Use and Criminal Sanctions: Essays on the Theory and Practice of Decriminalization* (Michie/Bobbs Merrill 1980).

6. The purpose of my filing this affidavit in this matter is to confirm that the central conclusion of the National Commission on Marihuana and Drug Abuse, also known as the Shafer Commission, in our 1972 report to Congress entitled *Marihuana, A Signal of Misunderstanding*, was that the social costs of imposing criminal sanctions on the tens of millions of otherwise law-abiding Americans who smoke marijuana exceeds whatever public health benefits are achieved by criminalization. Based on this conclusion, the Commission recommended that possession of small amounts of marijuana for personal use, and other consumption-related behavior, be decriminalized.


7. Approximately 200,000 Americans were arrested on marijuana charges in 1970, the last year for which data were available when the National Commission on Marihuana and Drug Abuse issued its report in 1972. Last year there were more than 800,000 Americans arrested on marijuana charges, including 89% who were arrested on simple possession and use offenses.

8. Over the 35 years since the Commission issued its report, I have remained convinced that the Commission's conclusion and recommendations were sound. Indeed, costs of criminalization have significantly increased.

9. A criminal conviction for a minor marijuana offense can result in a term of imprisonment; the loss of eligibility for student loans; the loss of subsidized public housing; the loss of employment; the loss of a driver's license, even if the offense was not driving related; the loss of food stamps, among other penalties.

10. More than 100 million Americans have smoked marijuana at some point in their lives, typically between the ages of 16 and 25. The overwhelming majority of these individuals have not become heavy or dependent users, have not used other illicit drugs, and have not suffered significant deleterious effects to their health.
